With effect from the Closing date, I hereby confirm that I have no outstanding claims for fees or expenses against the Company arising out of or in connection with my directorship or resignation thereof.

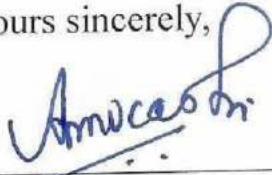
